PERSONAL DATA THAT WE PROCESS

Stichting Pocket Stories process your personal data by using our services and/or because you provide this information to us. Below you will find an overview of the personal data we process:

- Other personal data that you actively provide for example through your application, in correspondence and by telephone.
- Location data
- Audio and visuals from official Pocket Stories events and projects

SPECIAL AND / OR SENSITIVE PERSONAL DATA WE PROCESS

Our website and/or service does not intend to collect data about website visitors younger than 16 years old. Unless they have permission from parents or guardians. We cannot, however check if a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, so that data about children is not collected without parental consent. PURPOSE AND INTENT OF PERSONAL DATA STORAGE AND PROCESSING

Stichting Pocket Stories processes your personal data for the following purposes:

- Handling your payment and application
- Sending our newsletter
- To contact you to provide our services, if necessary
- Inform you about changes to our services and products
- Audio and visuals for our annual and impact reports, but never with personal contact information such as date of birth, address, phone number, email address and IP address.

Stichting Pocket Stories will protect the data files so that only the authorized personnel defined by Stichting Pocket Stories, have access to the file. These Stichting Pocket Stories authorized personnel may be Stichting Pocket Stories employees or subcontractors.

HOW WE LONG DO STORE PERSONAL DATA

Stichting Pocket Stories will not keep your personal data longer than is strictly necessary to achieve the goals for which your data is collected. After this data is no longer necessary, we will delete or anonymize data in our possession within a reasonable time frame, except such data as we determine may be needed to resolve disputes, enforce agreements, and comply with business, technical, or legal requirements related to our business.

SHARING OF PERSONAL DATA WITH THIRD PARTIES

Stichting Pocket Stories only provides information to third parties if it is necessary for the execution of our agreement with you or to comply with legal obligations to the Dutch government and/or European Union. We will never sell your personal data to third parties.

COOKIES, OR COMPARABLE TECHNIQUES, WHICH WE USE

Stichting Pocket Stories only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that comes with the first visit this website is stored on your computer, tablet or smartphone. The cookies that we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preference settings. We can also optimize our website with this. You can opt out of this cookies by setting your internet browser in such a way that it no longer saves cookies. You can also delete all information previously stored through your browser settings.

EVALUATE, MODIFY OR REMOVE DATA

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing or to object against the processing of your personal data by Stichting Pocket Stories and you have the right to data portability. That means that you can submit a request to us for the personal data that we hold from you in a computer file to you or another person, by your organization. You can request a viewing, correction, deletion, data transfer of your personal data or request for cancellation of your consent or object to the processing of your personal data to hello@ourpocketstories.org.

To make sure that the request for access has been made by you, we ask you for a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We respond as soon as possible, but within four weeks, at your request. Stichting Pocket Stories also want to point out that you have the possibility to lodge a complaint with the national supervisor, the Personal Data Authority.
